A Message from CAPPs President Matthew Johnston

On behalf of the Board of Directors of the California Association of Private Postsecondary Schools (CAPPs), I would like to welcome you to the 2017 CAPPs Legislative Policy Conference.

This year we are again confronted with many challenges in regards to our sector's ability to endure the coming years. The election of Donald Trump as the 45th President of the United States has released an avalanche of revenge legislation in California, as those on the far left seek to attack anything that is remotely promoted or connected to the Trump Administration.

While President Trump has never fully endorsed our sector in public, the fact that he has chosen not to continue the full out assault that was aimed at our sector the last six years of the Obama Administration was enough to signal to our opponents that they should continue the attack. That attack continues both on a State and Federal level.



We wish that our opponents would acknowledge that the two major reauthorizations of the laws governing our sector in California in just four short years, combined with major fee increases, have made Private Postsecondary Schools in California the most regulated and difficult State in the Union to educate and train students. This is not an accident. Our opponents have sought first to make our Institutions reporting as difficult and unfair as possible under the guise of "transparency" and now seek to weaponize the reporting results to shut our schools down.

No matter how many disclosures and signatures our students must sign, or how many restrictions and frankly unfair definitions of placement are forced on us, our adult students make the choice to attend our Institutions and that makes our opponents furious. As they seek to exercise the "nuclear" option through State Legislation, we must stand together as a sector to fight for our survival. Nothing less than our best efforts will be needed to turn the tide of hatred against us.

In more reasonable times, the value of our sector in educating, training and putting people to work in the State economy was recognized and appreciated. Now the attacks are based on nothing more than partisan elitism that proclaims anything other than public education will not do.

Our Conference theme "Advancing Opportunity" is based on the belief that time is short for us to change the course of the attacks directed at us and have a conversation with State Legislators about what differentiates our sector in a positive manner.

We are the Community that they represent. We educate and train in all areas but most of our students do not wish to pursue a four to six-year Academic Degree. They want fast and effective training that will land them an entry level career position.

We must organize the support of our students, faculty and alumni and direct them to have a conversation with their State elected officials about the legislation affecting us so negatively. It is my hope that your participation in this year's Legislative Policy Conference will lead to direct action on your part to eliminate the grave threats posed by the bad legislation we will review and the attacks mounted by our opposition.
